- **1.** Opening Prayer Father
- 2. Review August minutes- Jessica
- 3. By-laws review- Jose
 - a. Inclusion of Jk-2nd coaches in requirement to apply via a narrative and a vote in order to coach. Amend to a statement of desire. Only needed if more than one person is interested in the same position.
 - b. Recommendation to remove the requirement for all coaches to have an executive committee vote. There isn't always time for this (last minute decisions d/t numbers etc). Per Jose, doesn't necessarily need to be in a meeting. Could be completed in Band app.
 - c. At-large members: Chris asked what is the purpose? Per Jose, input, opinion.
 - d. Attendance at meetings. If you cannot attend, let Jose know your input on any discussion items.
 - e. Suggestion: If you miss three meetings in a year with zero communication, the executive committee has the option to vote you out
 - f. Question/discussion about executive committee right of refusal to assistant coaches. Coach/coordinator needs to notify someone of who their assistant coaches will be
 - g. Max family sport fee- up to the parent to track/ask via the athletics email address. Emily and/or Brian will own the task. (Gameday coordinator and treasurer); (current year only, will not refund past year fees). \$300 max.
 - h. Policies are a separate document from bylaws, and these will be reviewed/approved next meeting.
 - i. Funding vote by sitting members. Would this go to whole board vs. executive committee? Language is unclear. Change language to "51% of board members present"
 - j. Once they bylaws are approved, we do not change them again until the next year's review
- 4. Communication channels and ground rules- Jose
 - a. Timing allowed from gameday closure to submitting coach names. Coordinators need to know if gameday is being reopened after it closes so he can adjust numbers. Need a 6-week lead time between closure and season start. Should stay open for one month.
 - b. Preferred method of communication: Email is not ideal. Various other platforms such as Band can be helpful, but every activity/sport uses something different. Jose would like us to try Band and have coordinators/coaches use it and get parents to use it. We will solicit feedback after we've tried it out for a while.
 - c. Reasonable response time 2-4 business days (not resolution time)
 - d. Do we want to hyperlink email addresses to board members on website? Jose response is that they can use Band
 - e. Minutes- can be sent directly out to group after meeting no need to approve. Within three days if no objections they can be published. (within 7 business days).

- f. Jose does not want to use Share Point to share documents for the boardonly email and Band. Need a private group on Band.
- g. Agenda 3-4 business days in advance of meeting
